- L-istudenti ma jistgħux ihallu l-basket tal-iskola fil-loker x'hin tispicça l-iskola. Il-basket irid jittiehed id-dar kuljum;**
- L-istudenti ma jistgħux imorru hdejn il-lokers waqt il-hin tal-lezzjoni jew bejn lezzjoni u ohra;**
- Il-lokers jistgħu jintużaw filgħodu qabel l-assembly, fl-ewwel brejk u fit-tieni brejk BISS;**
- Il-lokers huma mharsa minn cameras tas-sigurta';**
- Il-lokers iridu jinżammu ndaf u bla ma jitwaħħlu stampi la barra u lanqas gewwa;**
- Il-lokers iridu jitbattlu sa l-aħħar jum ta` Mejju;**
- Hadd ma jista' juża l-lokers fin-nofs ta' nhari.**

I understand that I have to respect all conditions mentioned hereunder to make use of the locker for good purposes. I also understand that the school administration (that is, the Head of School and the Assistant Heads of School) has the right to preclude me from making use of the locker if I fail to abide to one of the following rules.

- a. **All lockers are School Property;**
- b. **The School Administration has the right to open the locker at any time, in the presence of the student who is making use of the locker. In case of student's absence another person in authority will be asked to stand in;**
- c. **A fee of €9 has to be paid for the use of the locker covering the three-year period at school;**
- d. **Student has to provide a padlock and to hand in a spare key to the Administration;**
- e. **The Administration will eliminate padlocks that will not match with the spare key provided. Consequently, the student will lose his/her right to make use of the locker;**
- f. **The student has to make use ONLY of the locker assigned to him or to her;**
- g. **The student has to keep in his/her locker only his/her belongings;**
- h. **The student is totally responsible for any irrelevant and/or unauthorized material in his/her locker;**
- i. **No material that is not related to the school can be kept in the locker;**
- j. **The school bag should not be left in the locker after school hours. The school bag should be taken home with student;**
- k. **Students can only make use of the locker during locker time;**
- l. **Time designed to make use of the locker is before Morning Assembly, during midmorning break and midday break ONLY;**
- m. **Lockers are protected by security cameras;**
- n. **Lockers have to be kept clean and no pictures or other material has to be fixed inside or outside the lockers;**
- o. **Lockers have to be emptied by the end of May;**
- p. **No one can make use of the lockers during half days.**
